<u>Michael Gill - Superintendent</u> ◆ Testing 20% of staff hosted by Elmira City SD and Dept of Health/Chemung County is going well, relatively quick process ◆ First week going full remote, some challenges, but overall successful with Google Classroom ◆ Created a sub-committee to discuss how athletics should be handled, awaiting more guidelines ◆ Delivered 7-day packet of food to 200 students today ◆

<u>Principal Report – Brandon Foley, Middle School</u> ◆ Cohen Middle School is identified as Targeted Support and Improvement (TSI) school because a subgroup in 2018-19 school year didn't perform well on state test – working to create a comprehensive improvement plan that will be presented to the Board in December for approval ◆ Three needs assessment surveys going out right now; 1 to students, 1 to families, 1 to teachers ◆ Teachers are doing a phenomenal job with remote learning, first 25 minutes of classes now start with live interactions, second 25 minutes designated for learning/catching up/break ◆ Home visits/outreach have helped with student attendance tremendously ◆ Sherry Moore (Science) and Jen Thomas (Library) assigned a fun STEM project for students to create a "contraption" to deliver Halloween candy safely with social distancing.

# a. RESOLUTION AUTHORIZING PARTICIPATION IN COOPERATIVE ENERGY PURCHASING SERVICE (NYSMEC) FOR ELECTRICITY

**WHEREAS**, Article 5-G of the New York State General Municipal Law authorizes municipal corporations to enter into cooperative agreements for the performance or exercise of services, functions, powers or activities on a cooperative or contract basis among themselves or one for the other, and

**WHEREAS**, Section 119-n of the General Municipal Law defines the term "municipal corporation" for the purposes of Article 5-G as a county outside the city of New York, a city, a town, a village, a board of cooperative educational services, a fire district or a school district; and

WHEREAS, Elmira Heights Central School District (hereinafter sometimes referred to as "Participant") is a "municipal corporation" as defined above; and

**WHEREAS**, this Board wishes for this municipal corporation to become or remain a Participant pursuant to the Municipal Cooperation Agreement For Energy Purchasing Services dated the 1st day of May 2005 (the "Agreement"), among municipal corporations collectively identified as the New York School and Municipal Energy Consortium ("NYSMEC") upon the terms of the Agreement and further wishes to authorize participation as an energy consumer as specified below.

**NOW THEREFORE, BE IT RESOLVED**, that this Board hereby determines that it is in the interests of the Elmira Heights Central School District to participate in the NYSMEC, and authorizes and directs Michael F. Gill to sign the Agreement/and or the Billing Schedule and Agreement for electricity on its behalf; and

**BE IT FURTHER RESOLVED**, that this Board authorizes the Administrative Participant (as defined in the Agreement) to prepare, advertise, disseminate and open bids pursuant to the General Municipal Law and to award, execute and deliver binding contracts on behalf of this Board for the purchase of electricity delivered to the delivery point of the local utility distribution company for the Participant's facilities, on a firm basis, for this Participant to the lowest responsible bidder as is determined by the Administrative Participant at a price for such commodity electricity not to exceed \$0.0736 cents per kWh for a term of at least one year and no more than three years commencing May 1,2021, and other terms and conditions, all as may be determined by the Administrative Participant, or to reject any or all such bids; and

**BE IT FURTHER RESOLVED**, that this Participant agrees to advertise said bid as may be directed by the Administrative Participant; and

**BE IT FURTHER RESOLVED**, that the officers and employees of this Participant are authorized to execute such other confirming agreements, certificates and other documents and take such other actions as may be necessary or appropriate to carry out the intent of this resolution.

This Resolution shall take effect immediately.

b. RESOLUTION AUTHORIZING PARTICIPATION IN COOPERATIVE ENERGY PURCHASING SERVICE (NYSMEC) FOR NATURAL GAS

**WHEREAS**, Article 5-G of the New York State General Municipal Law authorizes municipal corporations to enter into cooperative agreements for the performance or exercise of services, functions, powers or activities on a cooperative or contract basis among themselves or one for the other, and

**WHEREAS**, Section 119-n of the General Municipal Law defines the term "municipal corporation" for the purposes of Article 5-G as a county outside the city of New York, a city, a town, a village, a board of cooperative educational services, a fire district or a school district; and

WHEREAS, Elmira Heights Central School District (hereinafter sometimes referred to as "Participant") is a "municipal corporation" as defined above; and

**WHEREAS**, this Board wishes for this municipal corporation to become or remain a Participant pursuant to the Municipal Cooperation Agreement For Energy Purchasing Services dated the 1st day of May, 2005 (the "Agreement"), among municipal corporations collectively identified as the New York School and Municipal Energy Consortium ("NYSMEC") upon the terms of the Agreement and further wishes to authorize participation as an energy consumer as specified below.

**NOW THEREFORE, BE IT RESOLVED**, that this Board hereby determines that it is in the interests of the Elmira Heights Central School District to participate in the NYSMEC, and authorizes and directs Michael F. Gill to sign the Agreement/and or the Billing Schedule and Agreement for natural gas on its behalf; and

**BE IT FURTHER RESOLVED**, that this Board authorizes the Administrative Participant (as defined in the Agreement) to prepare, advertise, disseminate and open bids pursuant to the General Municipal Law and to award, execute and deliver binding contracts on behalf of this Board for the purchase of natural gas delivered to the city gate of the local utility distribution company for the Participant's facilities, on a firm basis, for this Participant to the lowest responsible bidder as is determined by the Administrative Participant at a price for such commodity natural gas not to exceed \$0.583 cents per therm for a term of at least one year and no more than three years commencing May 1, 2021, and other terms and conditions, all as may be determined by the Administrative Participant, or to reject any or all such bids; and

**BE IT FURTHER RESOLVED**, that this Participant agrees to advertise said bid as may be directed by the Administrative Participant; and

**BE IT FURTHER RESOLVED**, that the officers and employees of this Participant are authorized to execute such other confirming agreements, certificates and other documents and take such other actions as may be necessary or appropriate to carry out the intent of this resolution.

This Resolution shall take effect immediately.

First step is renovating the front doors and roof at TAE high school – leaks and cracks. Paperwork has been submitted and architects are planning. Hopefully to get that approval in December, lead time on ordering doors is 6 months.

Hunt completed the facilities review and prioritized renovations within a certain dollar amount. Time to think about the bigger projections. Look into energy savings that "pay for themselves"

# DISCUSSION

N-1 Orange Zone Status – no update from the Governor yet. Covid case numbers are still steady. Mr. Gill went through a power point presentation regarding the NYS guidelines for covid testing during Orange/Yellow Zone and what is needed if we want to attempt to bring students back in person while in Orange/Yellow zones. Orange zones required every student and staff be tested for covid within 7 days of in person start date and continue covid testing 25% of staff and students each week so all are tested within a 4 week cycle. Yellow zone requires 20% testing of staff and students each week. If test results return 9+ covid positives, we would have to go to remote learning again. District will put out survey to families to see what the interest is in going through this testing to reopen to hybrid model. District Leadership Team will review the guidelines, logistics, and review survey results.
