

MODIFICATION AGREEMENT  
THE UNIVERSITY OF ROCHESTER SCHOOL OF MEDICINE AND DENTISTRY  
AND  
ELMIRA HEIGHTS CENTRAL SCHOOL DISTRICT

This modification agreement (“Agreement”) is made and entered into as of this \_\_\_\_\_ day of \_\_\_\_\_, 2017, by and between the University of Rochester School of Medicine and Dentistry, a division of the University of Rochester, an educational institution chartered by the State of New York with offices at 601 Elmwood Avenue, Rochester, New York, 14642, hereinafter referred to as “University”, and Elmira Heights Central School District a New York State School District with offices at 2083 College Avenue, Elmira, NY 14903, hereinafter referred to as “Client”, collectively, are referred to herein as the “Parties”.

WITNESSETH

WHEREAS, the Parties entered into an agreement, hereinafter referred to as the “Service Agreement”, wherein the University agreed to provide Technical Assistance to the Client; and

WHEREAS, the Service Agreement had an effective date of August 9, 2016; and

WHEREAS, Attachment B in the Service Agreement set forth the number of hours that the services would be provided as well as the maximum amount of compensation that the Client would pay the University for such services; and

WHEREAS, the Parties have mutually agreed to modify certain terms and conditions of the Service Agreement, as set forth below; and

NOW, THEREFORE, in consideration of the mutual agreements and covenants contained herein, the sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. Effective as of February 1, 2017, Attachment B of the Service Agreement is hereby modified to provide that the number of hours for the Technical Assistance provided at the location of Elmira Heights shall be increased to 40, the number of hours for travel will be increased to 42, and the number of mileage instances will increase to 12.
2. Effective as of February 1, 2017, Attachment B of the Service Agreement is hereby modified to provide that the cost of the Technical Assistance provided at the location of Elmira Heights shall be \$6,200.00, the cost of the travel for technical assistance shall be \$6090.00, and the cost of mileage shall be \$1296.00; total cost of all services provided pursuant to the Service Agreement shall not exceed \$13,586.00.
3. All other terms and conditions contained in the Service Agreement shall remain unchanged.
