#### M-1 High School Schedule Survey Data Review

High School Principal Tom Boyanowski introduced Jessica Green (BOCES), Staff Development Coordinator. He gave a brief history of the high school schedule before, during, after covid closures, and reviewed the results of the scheduling survey that was given to students, parents, and staff. The results were clear that continuing in block schedule (similar to Horseheads and Elmira City), was favored by all groups. 
### Staff Comments from Scheduling Survey Results


### **Positives for Block**


- Fewer classes to focus on and less homework
- More time in class to ask questions
- Fewer Regents exams at one time
- Ability to take more electives
- Ability to take more credits/ACE
- Repeat a class in the same year vs waiting until next year
- Graduating early is an option
- Advanced regents option for lower level students especially in math
- Fresh start halfway through the year
- Not having the stress of the change going to traditional
- Option for skinnies (full year courses)
- MOST PARENTS & STUDENTS seem to prefer the way it is/ remain in block
- Can earn more credits
- A benefit for students: Opportunities to move ahead. Another positive is if they have a bad semester, they can redo it.


### Negatives for Block

- Longer periods to maintain focus
- A lot of material to process
- Missing time/attendance hurts more
- Harder on special ed students (focus, switching resource/support)
- Extended gap between core classes (math)
- Harder to get through the curriculum. (per teacher comments)
- Lack of training for teachers on how to use time
- Too many study halls & students are not utilizing study hall time when they have it
- Attendance concerns- when you miss a day or extended time periods it is difficult to make up work (Parent and teacher concern/ not student concern)
- Need more class options
- TEACHERS- way less seat time overall (not enough time to get through curriculum)- This is problematic/ especially for Regents classes.
- Change of schedules for Special Ed. providers leads to loss of continuity in caseload.
- Need to look at athletic requirements/ contract requirements
- Difference between first and second semesters regarding days in school and how 2nd semester is automatically shorter.





January 4, 2023

# N-1 Budget

This will be a standing discussion topic from here on out through the Budget Vote in May.

- This is just the start of our presentations and discussions on Budget Prep
  - We are awaiting... State of the State 1/10... Jan 17th Aid Runs (tbd)
- Last Budget process Priority:
  - reduction of reliance on Appropriated Fund Balance was one of our priorities.
- Other Priorities:
  - Maintaining current academic and extra-curricular programming, incl. Staffing levels.
    - Addressing academic challenges COVID impact continues.
  - Addressing communications for security and safety: radios
  - Equipment replacement cycle.
  - Vehicle replacement cycle.

## **N-2 Transportation**

- NYS Governor's march towards the electrification of pupil transportation.
  - This is moving forward pragmatic assessment, how would we do it?
    - Buses Charging Finances
    - Hurdle for Elmira Heights CSD: Storage and Maintenance.
- EHCSD Transportation Arrangement w/Horseheads Sunsetting.
  - Our status:
    - We own the buses
    - Drivers are our employees
    - Contract maintenance, parts, storage, as well as office and training space with Horseheads CSD.
- Transportation Study Proposal anticipated by week's end.
  - A light of sunshine aidable transportation assessment for safety??

### N-3 NYSED/NYSDOH Updates

- Joint Letter Dec. 5, 2022. This was a joint message encouraging good healthy practices like we do in any other year around the flu, but also state masks are "recommended" when in public indoor situations.
  - Recommendation vs. Requirements: Standard Position we do what is required.
- Recent Concern over Public Health and Health Planning Council Agenda(DEC)
  - This meeting is a regular monthly meeting.
  - Regulations have been continuously in place since the end of the emergency in 2021.
  - Per attorneys, "This is just a standard renewal of an authority of the Commissioner."
  - Though not "NEW", is seen as a concern for members of our community. We will monitor closely.
  - Vaccine Mandate Concern NOTE: No traction + not looking like it will get it.
  - Best advocacy on that issue is through local reps in Albany.
