BE IT RESOLVED that the Elmira Heights Central School District Board of Education approves the 2023-2024 Schuyler-Steuben-Chemung-Tioga-Allegany BOCES Board of Cooperative Educational Services Administrative Budget in the amount of \$8,252,542.

J-3 Senior Class Trip - approved

A motion was made by Jody Buckley, seconded by John Cole and carried 7-0 to approve the Senior Class trip to Hershey Park in Pennsylvania on June 14, 2023 for various activities.

J-4 8th Grade Trip - approved

A motion was made by Jody Buckley, seconded by Michael Lepak and carried 7-0 to approve the Grade 8 trip to Dixie Bowling lanes and Joycrest Skating rink on June 2, 2023 for various activities

J-5 Bus Garage Lease – approved

A motion was made by John Cole, seconded by Andrew Willard and carried 7-0 to approve the bus garage lease for the 2023-24 school year between the Horseheads Central School District and the Elmira Heights Central School District.

J-6 Maintenance Agreement - with Horseheads Central School District - approved

A motion was made by John Cole, seconded by Terrance Day, and carried 7-0 to approve the maintenance agreement for the 2023-24 school year between the Horseheads Central School District and the Elmira Heights Central School District.

J-7 Budget Resolution for 2023-24 - approved

A motion was made by Christopher Callas, seconded by Michael Lepak, and after a brief discussion on tax cap percentage calculations, expanding the number of PreK classrooms, the demand for extra supports, and that since NYS budget has not been set yet, the rate of expenditures will be kept the same, the plan will be to use more reserves to offset the state budget if the numbers come in less than predicted, the motion carried 7-0 to approve the following 2023-24 budget resolution:

Proposition Number 1 – (Budget)

Shall the following proposition be adopted, to wit:

BE IT RESOLVED that the proposed budget of \$27,875,079 of the Elmira Heights Central School District for 2023-24 be approved in accordance with Section 2022 of the Education Law and that the balance of said budget after applying available public moneys thereto be raised by a tax upon the taxable property of said District.

Adoption of this budget requires a tax levy increase of 1.79% which does not exceed the statutory limit of 1.79% for this school fiscal year and therefore does not exceed the state tax cap and must be approved by a simple majority, more than fifty percent of the qualified voters present and voting.

J-8 Property Tax Report Card - approved

A motion was made by John Cole, seconded by Andrew Willard, and carried 7-0 to approve the 2023-24 Property Tax Report Card as required by section 2601-a(3) of Education Law.

J-9 Capital Outlay Project 2023-24 - approved

A motion was made by Terrance Day, seconded by Andrew Willard, and carried 7-0 to approve the proposal from Hunt Engineers and Architects for the design services associated with the 2023-24 Capital Outlay Project contingent on the 2023-24 budget being approved by the qualified voters on May 16, 2023.

K-1 CSE Recommendations and Funding - approved

The Board of Education approved the student placement determinations from the April 18, 2023, CSE/504 meeting(s) and the funds to support such recommendations.

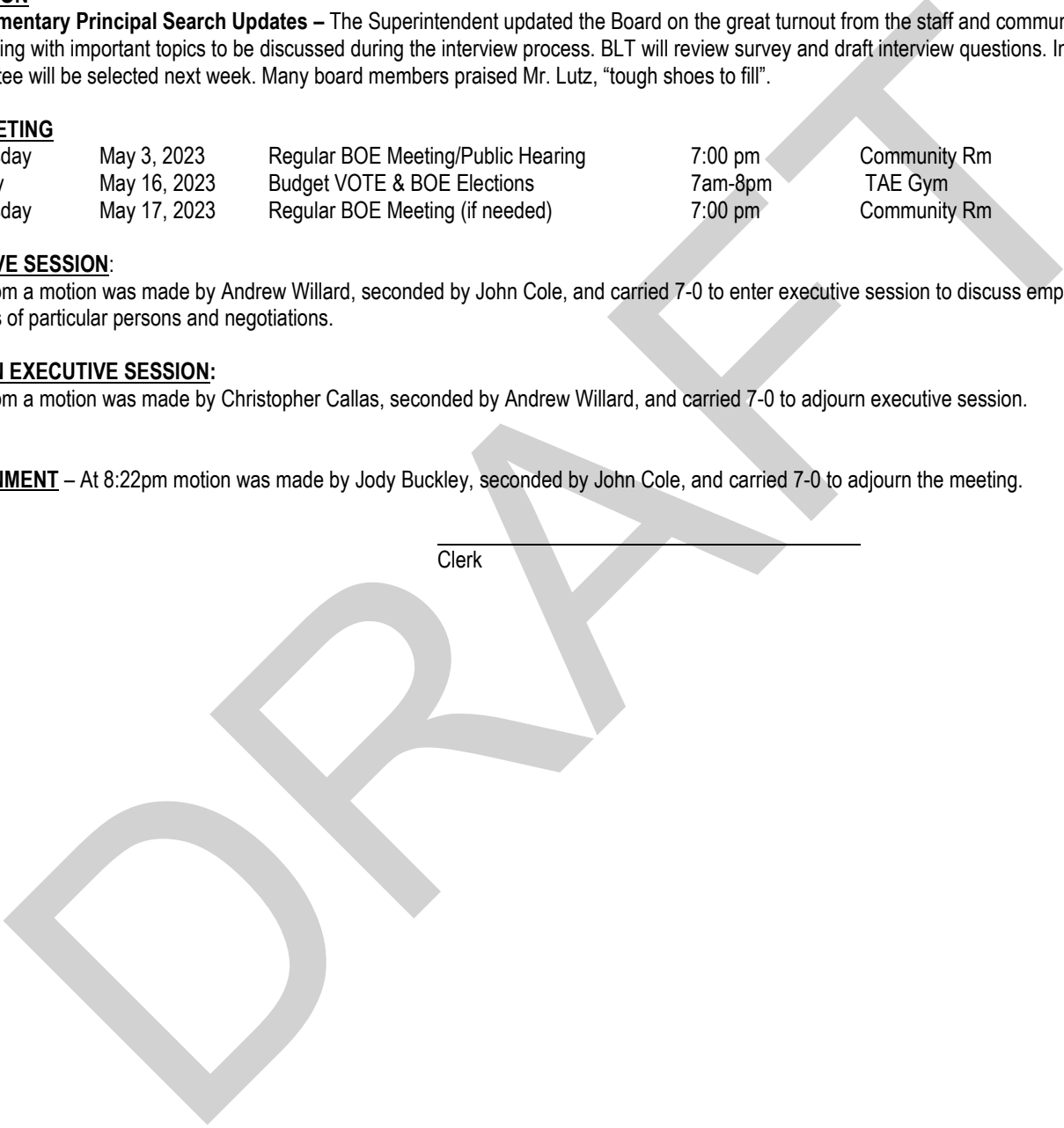

ADJOURN EXECUTIVE SESSION:

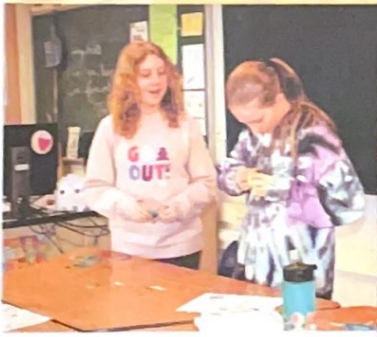
At 8:20pm a motion was made by Christopher Callas, seconded by Andrew Willard, and carried 7-0 to adjourn executive session.

ADJOURNMENT – At 8:22pm motion was made by Jody Buckley, seconded by John Cole, and carried 7-0 to adjourn the meeting.

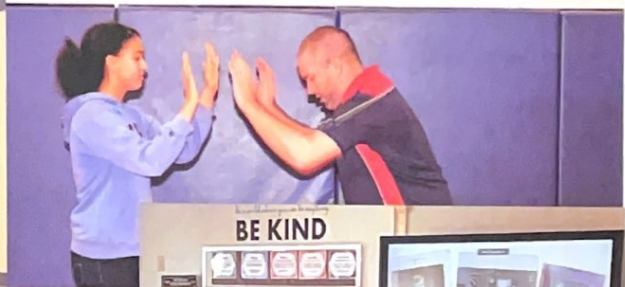
